



REGULATION (EU) 2019/1009

CE-MARKING FOR FERTILISING PRODUCTS

Regulation (EU) 2019/1009 (FPR) introduces CE marking for compliant fertilising products and includes a wide range of product types (e.g. mineral, organic/organo-mineral fertilisers, soil improvers, liming materials, biostimulants, etc.). CE marking is particularly attractive for fertilising product manufacturers, as compliant products may be commercialised across all European Union member states.

The FPR regulates the characteristics of the final product, as well as the component materials in all compliant fertilising products. The FPR establishes a common legal framework in the form of a toolbox, consisting of different pathways for compliant products to achieve CE marking. CE marking sets the standard for EU fertilising products in quality, safety and labelling.

Following the categorisation of the product into a Product Function Category (PFC) and the individual product components into Component Material Categories (CMC), specific Conformity Assessment Procedures must be followed in order to demonstrate that the requirements of the FPR are fulfilled. Some of them may require the involvement of a Notified Body.
